Article V, Section 2. Payment authority. Deleted vice president; added assistant treasurer. Payment authority expanded to include all payments, not just checks.	The President, Treasurer, and Assistant Treasurer shall have the authority to issue checks and all other budgeted and approved payments for the Association.
Article XII, Section 1.  Minimum requirements for Association policies and procedures.  Whistle Blower policy deleted because it is addressed elsewhere (Removal of Officers and Directors).  New policy added. Data Security, Data Management, and Data Access.	The Board shall establish policies and procedures necessary for the appropriate governance of the Association. These will include the following, at a minimum: Finance and Accounting; Conflict of Interests; Removal of Officers and Directors, and Data Security, Data Management, and Data Access.
Article XIII. Protection of Directors. Indemnification updated to clarify that designated Board volunteers are also covered	No Director shall be liable to the Association except for his/her own acts, neglects and defaults in bad faith. No Director shall be liable out of his/her personal assets for any obligation or liability incurred by the Association. TheAssociation alone shall be liable for the payment or satisfaction of all obligations and liabilities incurred in carrying on the affairs of CMGA. CMGA shall provide indemnification insurance for its Directors and Officers as well as designated Board volunteers.

#### Native and Non-Native Plants for a Sustainable Landscape - Nancy DuBrule-Clemente.

- Nancy founded Natureworks Horticulture Services in Northford, CT in 1983.
- The presentation shared Nancy's expertise on how to create a high quality ecosystem using a
  mixture of native and select non-natitve plants that support pollinators, birds, animals, and all
  the life with which we share our yards.
  - "We are all weavers of the web of life in our yards."
  - Cover for wildlife
  - Pollinator pathways
  - 70/30 native/non-native recommended by Doug Tallamy make plant choices within this context
  - Action plants for ecological function (e.g., elderberry, quince, blueberry, spice bush)
  - o Factors to consider length of bloom; late or early bloomer
  - Some varieties of plants may not be good for pollinators (e.g., no fruit, no thorns, double flowers)
  - Gardening with native/straight species from Connecticut will limit our gardening.
- "Go back to the beginning and soothe the souls of humans."
